



APPLICATION AND GUIDELINES FOR INSTALLING AND MAINTAINING A PORTABLE BASKETBALL HOOP

This application contains the guidelines for a portable basketball goal. You must review the guidelines set forth herein and complete the application on the third page of this document.

For your information, the Heddingham Athletic Club Community Association Board of Directors has adopted the following guidelines, which you must accept by completing and signing this application.

ITEM 1

The basketball goal must be portable. The definition of "portable" is something mobile and with wheels.

ITEM 2

The Architectural Review Committee (ARC) will not approve a portable basketball goal unless it can be shown that the area proposed for the basketball goal is large enough to assure that your neighbor's yard will not be unduly impacted by the use of the basketball goal. Therefore, you must submit a complete copy of this application to your neighbors on both sides of your home for their signature; however, you do not have to submit copies to your neighbors across the street from your home. Your neighbors on either side must sign the application.

- The owner of the portable basketball goal is responsible for any physical damage to their neighbor's property caused by the basketball goal. Physical damage to their neighbors' property can lead to the removal of the basketball goal at the owner's expense.
- When seeking approval for a basketball goal, you must indicate where your portable goal is going to be stationed.

ITEM 3

- A basketball goal cannot be placed along the street.
- The basketball goal must be put away when not in use and it should be placed in an area where it is not in full view.

ITEM 4

A basketball goal cannot be "*homemade*." The goal must be professionally constructed, painted, and maintained by the owner. The post for the basketball goal should be painted black, white, or some other suitable color. The backboard for the basketball goal should be white, clear, or some other suitable color. You should attach additional pages to your application setting forth all of this information. The basketball goal must be properly maintained and if it is damaged, bent or rusted, the owner must repair the basketball goal immediately.

GUIDELINES FOR INSTALLING AND MAINTAINING A PORTABLE BASKETBALL GOAL (Cont.)

ITEM 5

By completing this application, you acknowledge your understanding of the above referenced guidelines and you agree, on behalf of all owners of your property and all future owners of your property, that the failure to comply with the above referenced guidelines as well as the following additional guidelines will result in the removal of the basketball goal at the owner's expense.

The owner is responsible for insuring that people using the basketball goal behave in such a manner that all neighbors are not disturbed by the use of the basketball goal. Loud noises, such as screaming and music, will not be tolerated. No one may play basketball before 8:00am and after 8:00pm.

ITEM 6

The Architectural Review Board (ARB) may, from time to time, amend these guidelines. By completing this application, the owner accepts the fact that the guidelines may be amended and agrees to maintain the basketball goal in accordance with any amendment to these guidelines as adopted by the Hedingham Athletic Club Community Association Board of Directors.

ITEM 7

By completing this application, the owner acknowledges that the obtaining of a basketball goal is merely a "temporary" privilege granted to the owner by the Hedingham Athletic Club Community Association, which can be revoked at any time, with or without cause, by the Hedingham Athletic Club Community Association Board of Directors.

ITEM 8

By approving the use of a basketball goal, the Hedingham Athletic Club Community Association Board of Directors and ARC does not accept any responsibility whatsoever with regard to the basketball goal.

The ARC may at its discretion, on a case by case basis, approve a permanent basketball goal depending upon the size, location, etc. The approval of a permanent goal at a particular location for one member by the Association does not obligate the Committee to approve permanent basketball goals for all residents.
